

**INVITATION TO RE-BID FOR *SERVICE CONTRACT FOR THE SEPTAGE MANAGEMENT FOR THE MUNICIPALITY OF DINALUPIHAN, PROVINCE OF BATAAN***

1. The ***DINALUPIHAN WATER DISTRICT*** through the *corporate budget* intends to apply the sum of ***SEVENTEEN MILLION SIX HUNDRED THOUSAND PESOS (P 17,600,000.00)*** being the ABC to payments under the contract for ***SERVICE CONTRACT FOR THE SEPTAGE MANAGEMENT FOR THE MUNICIPALITY OF DINALUPIHAN, PROVINCE OF BATAAN / DWD#2021-05***. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The ***DINALUPIHAN WATER DISTRICT***, using a *multi-year* for a duration of *Two(2) years* Framework Agreement, through the corporate budget intends to apply the sum of ***SEVENTEEN MILLION AND SIX HUNDRED THOUSAND PESOS (P17,600,00.00)***;
3. The ***DINALUPIHAN WATER DISTRICT*** now invites bids for ***SERVICE CONTRACT FOR THE SEPTAGE MANAGEMENT for the MUNICIPALITY OF DINALUPIHAN, PROVINCE OF BATAAN***. Delivery of the Services is required within *ten (10) days from the receipt of Notice to Proceed*. Bidders should have completed, at least five *(5) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary *“pass/fail”* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
5. Prospective Bidders may obtain further information from ***DINALUPIHAN WATER DISTRICT*** and inspect the Bidding Documents at the address given below during *office hours (Mondays to Fridays – 8:00 a.m. to 5:00 p.m.)*.
6. A complete set of Bidding Documents may be acquired by interested Bidders on *September 30, 2021* from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Seventeen Thousand Six Hundred Pesos (P17,600.00)***. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.

7. The *DINALUPIHAN WATER DISTRICT* will hold a Pre-Bid Conference on October 07, 2021 at its office at 1:30 p.m. and/or through video conferencing or webcasting via Zoom (under DWD account), invitation will be sent via email, which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below, (ii) online or electronic submission as indicated below, or (iii) both on or before *October 19, 2021 (12:00nn / 1:30 p.m.)*. Late bids shall not be accepted.
9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
10. Bid opening shall be on *October 19, 2021 at 1:30 p.m.* at the given address below and/or via Zoom (under DWD account). Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Dinalupihan Water District reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
