## INVITATION FOR NEGOTIATED PROCUREMENT

## SUPPLY AND DELIVERY OF WATER TANK TRUCK

- 1. In view of two failed public biddings, the Dinalupihan Water District's (DWD) Bids and Awards Committee(BAC), invites interested bidders to participate in the negotiation for the Supply and Delivery of One (1) Unit Water Tank Truck, in accordance with Section 53.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184, otherwise known as the Government Procurement Reform Act.", the Dinalupihan Water District through its Corporate Budget intends to apply the sum of THREE MILLION FIVE HUNDRED THOUSAND PESOS (P3,500,000.00) ONLY being the Approved Budget for the Contract (ABC) to payments under the contract for the SUPPLY OF WATER TANK TRUCK (for potable water) for DINALUPIHAN WATER DISTRICT.
- 2. The Dinalupihan Water District BAC will hold a meeting/negotiation with all interested bidders on <u>July 25, 2019, 2:00 P.M.</u>, at Dinalupihan Water District Office, Pag-asa, Kataasan, Dinalupihan, Bataan;
- 3. The Eligibility Documents, Technical Proposal, and the Best and Final Offer stated in the attached checklist shall be submitted in one (1) original and two (2) duplicate copies on or before <u>July 30, 2019, 1:00 P.M.</u> at Dinalupihan Water District's Office, Pag-asa, Kataasan, Dinalupihan, Bataan.

The opening of the Eligibility Documents, Technical Proposal and Best and Final Offer will be on July 30, 2019, 1:30 P.M. at Dinalupihan Water District's Office, Pag-asa, Kataasan, Dinalupihan, Bataan

Best and final offers received in excess of the ABC shall be automatically rejected.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4. Interested Bidders may obtain further information from the DWD-Bids and Awards Committee (BAC) Secretariat at the address given below during 8:00 AM - 12:00 NN and 1:00 PM - 5:00 PM on weekdays except Holidays.
- 5. The Dinalupihan Water District reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
