## INVITATION TO BID

### SUPPLY OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF NEW WATER SUPPLY SYTEM AT BRGY. DALAO, DINALUPIHAN, BATAAN (DWD#2018-01)

1. The *Dinalupihan Water District (DWD)*, through its Corporate Budget intends to apply the sum of **THREE MILLION NINE HUNDRED SIXTY THREE THOUSAND EIGHT HUNDRED AND THIRTY TWO PESOS ONLY (₱3,963,832.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply of Labor and Materials for Construction of New Water Supply System at Brgy. Dalao, Dinalupihan, Bataan under Contract No. DWD# 2018-01. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Dinalupihan Water District now invites bids for the Supply of Labor and Materials for New Water Source at Brgy. Dalao, Dinalupihan, Bataan. Completion of Work required is One Hundred Twenty (120) calendar days. Bidders should have completed within the last five (5) years (2013 to present) at least three (3) projects or a contract similar to the Project. For this purpose, similar contracts shall refer to the Construction of New Water Supply System projects.

The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184) otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested Bidders may obtain further information from the DWD-Bids and Awards Committee (BAC) Secretariat at the address given below during 8:00 AM – 12:00 NN and 1:00 PM – 5:00 PM on weekdays except Holidays.
5. A complete set of Bidding Documents may be purchased by interested bidders from the BAC Secretariat at DWD Office, Kataasan, Dinalupihan, Bataan and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Php 3,900.00**.
6. The Dinalupihan Water District will hold a Pre-Bid Conference on **February 15, 2018, 1:30 P.M.** at the Dinalupihan Water District Office, which shall be open to all interested parties who have purchased the Bidding Documents.

*Only bidders who purchased the bidding documents are allowed to attend or ask questions.*



Bid opening shall be on **February 26, 1:30 P.M.** at the Dinalupihan Water District Office. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. Eligible Bidders shall submit a Certified True Copy of Valid PCAB license: "Small B"
9. The DWD reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
